## **LETTING PEOPLE INTO THE MEETING--5:30**

### **CALL TO ORDER/WELCOME ADDRESS--5:35pm**

Musibau Francis Jimoh (GSA Vice President of Internal Affairs)

It is good to see everyone and today we are especially thankful for a successful and peaceful transition of power. Before we go any further I want to make sure I have your permission to start recording as well as to remind everyone who the voting members are (representatives from the academic student councils). We have three items up for a vote today.

### **UPDATES FROM GSA LEADERSHIP--5:35**

JP Santos (GSA President)

- I am working to increase accessibility and awareness of resources for graduate students through:
  - Create an infographic with information about graduate and professional student resources that are based on student needs and questions.
    - Goal is to finish the infographic by the end of this quarter
    - Departments will post these resources on their websites, hopefully to help students navigate resources on campus
  - Hosting a Presidential Town Hall with VC Gordon, VC Beck, and Dean Ettner on Feb 4th around lunchtime
    - It's not about COVID but more about campus resources like CAPS
    - Sign up to attend via the [registration link](#)
    - We will post FAQs from this meeting on the GSA Facebook page
    - Comment from Susan Ettner: You're always welcome to ask me questions, but please don't be offended if I refer you to the relevant unit for the answer if it's not us. Besides Student Affairs, the Graduate Division's purview also often gets confused with that of the Graduate Council (they make policy, we implement).

### **FORUM ENGAGEMENT--5:45**

- Campus commitment to testing

- Identifying people who are spreading COVID and do not know it
- Contact tracing and isolating people as necessary
- Three brick and mortar test sites in addition to a bus (largely devoted to graduate students)
- Anyone living, learning, or working on campus is required to get tested 2x per week
- Graduate students living in university housing are required to get tested once every two weeks if they are not coming to campus
- Confirmed campus cases (1837 on campus)
  - Spike after the break
  - Testing by location (5200 people per day tested on Tuesday, January 20th)
  - Positivity by cohort from last week
    - 26% positivity rate for students involved in Greek life
      - These are students who are Greek affiliated and not necessarily living in the fraternity and sorority houses on campus, but off campus in non-university housing. Because of this, we cannot force them to get tested or isolate.
    - Relatively low positivity rate in general
- Vaccine Priority
  - We are at the tail end of phase 1A (healthcare workers, COVID test center workers, etc.)
  - Soon moving into phase 1B (ResLife, Housing Custodial Staff, employees over 65, pre-K teachers and staff, research faculty, staff, **graduate students** who are part of research ramp up, other on-site employees)
  - All students will be vaccinated in phase 2
    - Broad vaccination available to the general public will likely begin in April or May
    - Hard to get the necessary supply of vaccines
    - Ackerman Ballroom will be converted into a vaccination hub for the campus
  - Ashe will provide vaccines (two doses, no cost to students)
  - The order in which students are vaccinated may be determined by randomization (those with comorbidities will be vaccinated sooner) or through the social vulnerability index (based on zip codes and geared toward addressing historic unequal access to healthcare)

Question from Jacob: What counts as a student employee? Would readers or GSRs be eligible for that phase?

Response: Yes, if you have an employment position (GSR, TA, etc.) you will be included in phase 1B and will be reached out to soon for vaccination.

Question: Are there certain types of allergies that could make it risky to get the vaccine?

Response: It depends on the kind of allergies. Talk to your healthcare provider about whether or not you might be at risk of having a more severe allergic reaction to the vaccine and how to handle that.

Question from Alex: What should students who are out of state do to get the vaccine?

Response: It depends on what campus will do with opening in the fall (Will we vaccinate students upon their return to campus or while they are away?) If you get the vaccine while you are away from campus, you will need a referral from Ashe (if you have UCship). We can vaccinate you in the fall, but cannot require it because of the vaccine's Emergency Use Authorization (EUA) (this could change though) through the FDA. It may be required at some point for undergraduate students living in university housing.

Follow up from Alex: So just to sum up, students should contact their primary care physician for a referral, correct?

Response: It is too early for that now unless you have underlying health issues, but once we get to that phase and begin vaccinating students more broadly (we are probably about two months away from this), then yes.

Question from Amira: Will the fact that the vaccine comes at no cost to students be subject to change?

Response: No, the government is paying for it, so you should be covered. If it becomes an annual vaccine like the flu shot, then this status might change.

Follow up from Amira: And in terms of our age group, is there a date by which we will be vaccinated?

Response: If you are over 65, you are next. Encourage those folks to get in touch with their primary care providers. For the rest of you, it will probably be about two months before we are able to get you vaccinated, but this new administration may be able to make this happen sooner.

Question Akash: Does Ashe have a recommendation for a specific number of people that need to be vaccinated before campus activities can resume?

Response: That is a great question for VC Beck when he does his presentation.

Question from Karen: Who is the “we” that will be vaccinated by April/May? Students? The nation?

Response: Employees are part of the 1B phase that we are moving into now, so you, Karen, will be on the list and be contacted in the next few weeks because you are a UCLA employee. This 1B group also includes student employees such as TAs. Students who do not work for the university will have to wait until phase 2 (i.e April/May).

Question from Elyse: When we say that students will be vaccinated by April/May is that the first or second does?

Response: We are hoping that the 1st dose will be administered by April/May and the second will shortly follow.

Question from Akash: Is there anything we should be doing before getting the second dose of the vaccine?

Response: No, but you should be aware that most side effects come after the second dose. These are things such as pain at the injection site.

Question from Amira: What do you recommend for us to do to help encourage people to get the vaccine and educate them about it?

Response: Getting the word out is really important. Anything GSA can do to try to get through falsehoods would be very helpful.

Francis: We have a few minutes left before the next segment, so I will offer this time to JP to give us updates on the budget.

JP: We are planning to pass the budget with surplus assumptions during the week 6 GSA Forum meeting. The money you did not spend last year will be carried over, and a lot of councils did not spend their money last year because of the pandemic, so you will see this in the carryover.

During the week 6 meeting, we should also have a discussion about creative ways to spend money.

### **FORUM ENGAGEMENT--6:15**

Michael Beck (UCLA Administrative Vice Chancellor)

- Housing projects
  - We recently acquired the Boulevard Apartments (on Santa Monica Blvd)
    - 337 units→ priority is medical residents and graduate students
    - There is a Target in the basement
    - Keystone, Mentone and Rosetone renovations
  - Improvements in security in response to package and bicycle thefts
- Farmer's market
  - Trying to get food to students for below market prices. Some of these activities have been impeded by the pandemic.
  - The next one is next week.
  - We are trying to ensure contactless pick up for students right now.
- BruinGo Transit pass
  - Unlimited rides on major bus companies in Westwood: Big Blue Bus (Route 17 now goes through Weyburn Ter.), Culver City Bus, Metro Bus, and Rail
  - Works with commuter lines as well (Antelope Valley, Santa Clarita, Long Beach Transit, etc.)
  - The Macgowan Turnaround will also be added to the Big Blue Bus route for the convenience of students going to North Campus
  - You can pick up your pass at the Central Ticketing Office
- Sepulveda Pass Transit Corridor Project
  - Rail project that would connect Sherman Oaks to LAX (there would be a stop at UCLA)
  - The project will hopefully be completed by 2028, but this is optimistic.
- Body cameras for campus police
  - Implemented this past year, and considered as best practices in policing. It is a very useful tool to create police accountability and help settle disputes about incidents.
  - Limitation: it only captures what it can see and it does not show everything.
  - Patrol officers and sergeants wear them and they are integrated with the in-car video→ cameras automatically get turned on when the car's sirens are turned on
    - Officers have no ability to edit or delete footage
- Spring Break Travel

- We are discouraging travel and encouraging isolation and testing for students who travel
- There is currently a quarantine in place for travel outside of the Southern California area (may be lifted by then)
- Would vaccinated individuals be exempt from the quarantine? Unclear for now.
- Future course scheduling
  - Virtually everything will be remote in Spring 2021
  - There may be more in person components at the graduate level in the Spring, especially in labs (classes that make use of specialized equipment/facilities)
- Summer 2021:
  - We have not made a final decision, but it will likely be mostly remote
- Fall 2021:
  - Mostly in-person but with face coverings and other mitigation measures
  - Some larger lectures may still be remote
  - We are anticipating have 75% occupancy in housing, but no triples
- I am also happy to answer questions about the COVID task force and vaccination efforts on campus.

Question from Akash: I will ask you the same question I asked John, does Ashe have a number of people that need to be vaccinated before campus activities can resume?

Response: The vaccine cannot be required but that could change before the fall. There is no specific number. We are following the guidance from LA County. Students will be vaccinated by the end of spring or early summer. We want to get them their two doses before they leave for other areas during the summer.

Question from JP: Firstly, I want to acknowledge everything you have been doing with the COVID task force. Secondly, I was wondering about requiring students to get vaccines and how that would work.

Response: Currently, we are not allowed to require it. If it were provided a regular FDA approval instead of the EUA, we may make it a requirement for students like the other immunizations they are required to get. This might not happen in time for the fall.

Question from JP: When they try to advocate for in-person classes on the department level they are told that it is up to the future planning task force, but it's really up to LA County. Would there be an openness to conduct a Town Hall addressing international student concerns related to this?

Response: It is an issue that tends to come full circle. We currently are not offering many courses in person, per LA County guidance. We understand that first year international students need to have a hybrid or in person class for their visa applications. Some universities are listing courses as hybrid (they are gambling that they can offer this). UCLA does not want to take the risk with students' visa applications being negatively affected if they cannot provide hybrid courses.

Response from Susan: The graduate courses currently approved for being in-person/hybrid have to meet the following criteria set forth by LA County DPH: Essential workforce sector; course is required (as in, it's listed as part of official program requirements); course is taken at the end of the program or if earlier, must be part of a "lockstep" program; course cannot be taught entirely online (meaning there is some resource that is essential to the course that can't be accessed online; it's unfortunately not enough just for the course to be better in person).

Question from Amira: What about students who are trying to come back to the U.S. after doing research abroad especially in terms of having gotten the vaccine? Will the vaccine be required for reentry?

Response: We have a much different administration leading the federal government that is more welcoming. Additionally, because of the EUA, we cannot require the vaccine right now, but that may change. To end on a more positive note, we are seeing a steep drop in hospitalized individuals in LA County, which indicates that we may be on the other side of that curve and that things may be improving.

I actually have two items to bring to a vote. The first concerns the approval of the Elections Calendar:

### **RECOGNIZING ELTS AS A SINGLE DEPARTMENT IN THE HUMANITIES COUNCIL\*--7:13**
